## INTRODUCTION

The following pages, including Appendix I, are a digest of the early minutes of the Pond Creek Primitive Baptist Church, located on Meeting House Branch of Pond Creek, near Belfry, in Pike County, Kentucky. This Church is often called the "Old Pond" Church.

The purpose of making this digest was to secure information of historical and genealogical value, and to aid in preserving the information contained in these minutes, which have, luckily, so far, escaped destruct-

ion by fire or other misadventure.

The digest was first made (and completed on March 30, 1953) from the minute book purchased by the Church and into which the contents of three older minute books were transcribed by A. R. Hatfield, Clerk of the Church, in the year of 1908; excepting that the digest for the period from December, 1869, to November, 1892 (inclusive) was made from the original Church Minute Book No. 2. Both of these books were in the possession of Fairchild Runyon, who was the Clerk of the Church in 1953.

A short time later, the original Minute Book No. 1 was found and the transcription from that portion of the minutes was corrected to correspond with the record in

the original book.

The lists of names of members of the Church, the dates of meetings, and everything in quotations, were copied (as exactly as possible) as written (and spelled) in the minute books.

The period from 1901 to 1949 is covered very briefly

in Appendix I.

Appendix II contains exact copies of papers concerning the Church, which were, in 1953, in the possession of Amos Runyon and Fannie J. Runyon, of Belfry, Kentucky.

I may copyright this book; if so, the readers are hereby granted the right to copy and publish portions of it for genealogical and historical purposes.

## Constitution

1843

May 13" "An arm of the Baptist Church of Jesus Chris at the Mouth of Mate Creek, Logan County, Va known by the Name of Enon, Church, hath granted the within members, the Liberty of becomeing a constitution on Pond Creek which Constitution was Attended to by Elders John Ferrell and John Wallis on the day above Named, and Made choice of John Wallis as their Pastor to take the oversite of this Church on Pond Creek known by the Name of Pond Creek Church, in Pike County Kentucky,"

"May the second Saturday 1843 the Church Met and after worship proceeded to Business, 1st Called for feloship found all in order, then proceeded to chooseing deacons. Made choice of Brethern Albers Mainnord, and John McCoy, then choose Brother Jessee Ball, Moderator, and Adron Runyon Clerk then adjourned till our Next meeting Signed by order of the Church, Adron Runyon, Clk."

June 7th, 1843 "the Church met a greeable to and pointment and after prayr by the moderater, proseeded to Buisiness 1st called for fellowship and all found in order 2ly for Reffarance and none 3ly for Experance an two come forowed and told wat the lord had done for them, adJorend til our next meeting done and orded by the church. "the case of Daniel Scott, and W McCoy, was lade over tell our next meeting, motion made that Brother John Varner be Exclded, and seconded, motion made and seconded that Brother John Ferrel bee chosen as our paster Motion made and seconded that Brother daniel Scott, and Ali Smith, McCoy, bare our next letter to the Sociation".

September the Second Saturday 1844. "Aly Smith, act as clerk" "found Wm McCoy, and Daniel Scott, and found and Settled by the Comity composed of A. Smith, J. Akers, Wm Taylor, of J - McCoy. Motion made that William Taylor, and Alvis Manord, to beare the letter. Asingnd by Aly Smith, C.l.k."

October and November 1844. No record of Church meeting.

Aprile the Second Saturday 1845. "motion made and second that BenJamine McCoy, and James Jowns, bee noticed to the next chirch metting why they do not attend and John McCoy Chareles Staton notice them" "Alvis Mainord, Moderator, Adron Runyon, Clerk,"

May the 2 Saturday 1845. (Minutes not signed.) "called for grievance and found a complaint against James Jowns and Excluded him and the case of BenJamine McCoy, taken up and Exclded him done and Signed in behalf of the Church. motion made and second tat Brother William france bee Silenced from Speeking in publick in the bounds of the Church".

June the 2 Saturday 1845. (Minutes not signed:) "called for grevince and Brother Wm talor, compland aganst Brother James Blackbern and Brother Levi Roman it taking up and tride by a commity and the commity found no grevinse then all Settled by James for four dollars"

July the 2 Saturday 1845. (Minutes not signed.) "motinon and Seconded the Brother Brewster Baptise those members and they bee attach to the Pon Creek Church". (Names of "those members" not given.)

August the 2 Saturday, 1845. Adron Runyon, Clerk. "1st cauld for fellowship and found brother John Smith, grievd with Brother WM France and lade over tel our next meeting motion made and Second that Brother Jonathan Akers git his letter from this Church ordered that a leter be Rote for our next association, Brother Alvis Mainnord, and Ali Smith and Adron Runyoun bee apponted to bare the Same then opend a dore for experiance and Receivd one by letter".

September the 2 Saturday 1845. A. R. Clk. "William Talor and Brother Levi Roman appointed to notice Brother John Smith Sin and John Smith June to tend the next church meeting then Red the letter for the Sociation and 75 cts put in for the prenting the minnets".

November 1845. (No record of any meeting.)

December the 2 Saturday 1845. Church met. Minutes not signed.

January the 2 Saturday 1846. A. R., Clerk. "Brother William france cald for a letter for him and his wife, and granted".

March the 2 Saturday 1846. "motion made and second that Brethern Joh Smith Jun and James Blackben and John Smith Sin to attend the next Church meeting to Show Cause Why they have not fild ther Seets and that Brother Wm talor and Levi Romine to notice James Blackbern and that Brother Charles Staton notice the John Smiths". (Minutes not signed.)

"the pon Creek Church met according to appointment after prayr by the moderater proseeded to buisiness ist called for greevince and found all in order 21d for Refferance and none 3ley to try thee members to fill ther Seet and Brother John Smith Sgn his Zexcused bee taken and the case of James Blackbern taken up and dismissed then motion made and Second that Sister Jane Retherford bee noticed to attend the next Church meeting to Show Cause Why Shee is dissatisfied to live in this Church and Brother Staton and Brother John Smith notice hur then opend a door for the reseptoin of members and Recevd two by letter, done and Signed in behalf of the Church, A. Runyon, Clk".

May the 2 Saturday 1846. Church met. (Minutes not signed.)

June the 2 Saturday 1846. Church met. A. R., Clerk.

July the 2 Saturday 1846. A. Runyon, Clerk. "motion made and Second that Sister Retherford bee notice to attend the next Church meeting".

August the 2 Saturday 1846. A. Runyon, Clerk. "3ly for a letter to Send to our next association and that A. Runyon and Wm talor, write it then adJourn tel our next meeting".

Sept the 2 Saturday 1846. Aly Smith, Clk "3 A Clerk appointed by Church 4" leter rcd 5 brethern appointed to bar the Lete Alvis manon John McCoy Daniel SCott Aly Smith. rec Catharine Manard by baptisms".

Oct 1846. (No record of any meeting.)

November the 2 Saturday 1846. Church met. (Minutes not signed.)

December the 2 Saturday 1846. Church met. A. R., Clerk.

Jan the 2 Saturday 1847. A. Runyon, Clerk. "Brother James Blackbern grevd at Levi Romins and A Runyon and Wm Talor and John McCoy appointted to talk to him".

Febuay the Second Saturday 1847. (Minutes not signed.) "the Case of James Blackbern aganst Levi Romine taken up and Setled by a Commity".

March 1847. (No record of a business meeting.)

April, May and June, 1847. Meetings held each month on the Second Saturday. (Minutes not signed.)

July the Second Saturday 1847. (Minutes not signed.) "motion maid and Second that the assosaation bee held at the pond Creek Church in 1848 then oppend a door fo the Recepsion of members and Received one by letter".

August the 2 Saturday 1847. (Minutes not signed.) "then James Blackburn made a complaint aganst Levi Roman for not paying 2 dollars tat the commity found aganst him and Excluded him and Br. Wm Talor be Excluded by his owe Request then motion made that a letter bee Rote and Aly Smith and Alvis Mainnord, and A. Runyon Rite it motion mad that James Retherford bee noticed to attend the next Church meeting and Brother A. Smith notice him".

September the 2 Saturday 1847. A. Runyon, Clerk. "called for grievince and James Retherford ExCluded, them a letter Rote and mesangers A Mainnord and A Runyon appointed then money made up for prentin the minits one dollar".

Oct 1847. A. Runyon, Clerk. Meeting held. (Day not given.)

November the 2 Saturday 1847. A. Runyon, Clerk.

December, 1847. (No record of any meeting.)

January the Second Saturday 1848. Meeting held. (Minutes not signed.)

February the Second Saturday 1848. Adron Runyon, Clerk.

March and April 1848. (No record of meetings.)

May the Second Saturday 1848. Meeting held. A. R., Clerk.

June 1848. (No record of a meeting.)

July the Second Saturday 1848. Meeting held. A. R., Clerk.

August the Second Saturday 1848. (Minutes not signed.)
"A. Runyon, and A. Mainord, write letter to the assosiation, then motion made and Seconded that Brother Ali Smith, and Brother Charles Staton, beare the letter".

September the 2, 1848. Adron Runyon, Clerk. "recd the church letter and made up one dollar, for the printing the minuets".

October, November and December, 1848. (No record of meetings.)

January the Second Saturday 1849. A. Runyon, Clerk. "motion made and seconded that John Mainord, be excluded, thirdly that John Smith, Jun, be excluded".

February the Second Saturday 1848 (evidently should be 1849-C.R.). Meeting held. Adron Runyon, Clerk.

March the 2 Saturday 1849. (Minutes not signed.) "for greveances and Jas Blackburn grevied with Wm Romans and wife for warent him and turnd out Wm Romans senr and Nancy his wife laide over tell April meten".

April the Second Saturday 1848 (evidently should be 1849 - C.R.). "refference called for and turned out Nancy Roman". Ali Smith, Clerk.

May 1849. (No record of meeting.)

June the 2 Saturday 1849. Meeting held. A. R., Clerk.

July the Second Saturday 1849. A. Runyon, Clerk. "motion made and Seconded that the Mate Creek association be organised and was done, done in be half of the church 1849".

August the second Saturday 1849. A. Runyon, Clerk. "motion made and seconded that Adron Runyon, Right the letter to the Mate Creek Assosiation motion made and seconded that Brother Alvis Mainord, and Charles Staton, and John McCoy, beare the same".

September the 3rd Sunday 1849. Adron Runyon, Clerk. "the Pond Creek met and prepaid money for the printing the minuets \$1,17 done and signed by order of the church".

Oct 1849. A. Runyon, Clerk. "a motion made and Second that Brother John trout notice Brother John Smith to fill his seat".

November the Second Saturday 1849. Adron Runyon, Clerk. "made the inquirey of John Smith, about his long absence and his excuse taken".

December the Second Saturday 1849. A. R., Clerk. Meeting held.

January and February 1850. Meetings held. Adron Runyon, Clerk.

March the Second Saturday 1850. Adron Runyon, Clerk. "found complaint against James Blackburn and excluded him by his owne request" "motion made and seconded that Brother John McCoy, be noticed to fill his Seat and that A. Runyon, notice him".

April and May (Second Saturday) 1850. "No church meeting". (Statement signed by A. Runyon, Clerk.)

June the Second Saturday 1850. Adron Runyon, Clerk. "opened the door for the reception of members, and received - Richard Williamson, by experence done by order of the church this the 8" day of June 1850".

July the Second Saturday 1850. Adron Runyon, Clerk. "motion made and seconded that A. Runyon, and A. Mainord, Right a letter to the Mate Creek assosiation, also that A. Runyon, A. Smith, and A. Mainord, have the same done in behalf of the Church".

August the Second Saturday 1850. Adron Runyon, Clerk. "the letter prepaired and money made up the amount  $$1\frac{75}{100}$$  done and signed in behalf of the church".

September the Second Saturday 1850. Church met. A. Runyon, Clerk.

October the Second Saturday, 1850. Adron Runyon, Clerk. "found grievence with Pegey McCoy, and appointed Jane Runyon, and Haret Mainord, talk with her".

November the 2 Saturday 1850. Adron Runyon, Clerk. "1st called for grievence and excluded Adron Runyon, Pegy Blackburn, and Pegy McCoy,".

December 1850. "No church in December 1850".

January the second Saturday (year not given - C.R.). Ali Smith, Clerk. "appointed A. Smith, Clerk, then opened the door of the church then restored Adron Runyon,".

February and March, 1851. No church.

April the Second Saturday 1851. Adron Runyon, Clerk. "2ly for the appointment of the a clerk and appointed Adron Runyon, for their Clerk,".

May and June, 1851. No church.

July 2 Saturday 1851. Church met. Adron Runyon, Clerk.

August, 1851. A. Runyon, Clerk. "3ly appointed A. Runyon, to right a letter. 4ly appointed Charles Staton, Alvis Mainord, and Adron Runyon, to beare the same to the next assosisation".

September the Second Saturday 1851. (Minutes not signed.) "motion made and seconded Rebecca May, and Mary an May, be excluded,".

October 2 Saturday 1851. A. Runyon, Clerk. "application made to the church by A. Mainard, for a letter for Sallie Deskins, Christina Jownes, and granted by the church".

November and December (2 Saturday) 1851. Church met. A. R., Clerk.

January, 1852. (No record of church being held or church business.)

February the Second Saturday 1852. Adron Runyon, Clerk. "motion made and seconded that Brother John McCoy, notice to fill his seat".

March the Second Saturday 1852. Adron Runyon, Clerk. "3ly motion made to exclude Brother John McCoy, and layed over tel next church meeting".

April the Second Saturday 1852. Adron Runyon, Clerk. "the case of John McCoy, come up and he was excluded 3ly Tilda Farley Joined the church".

May, June and July (2 Saturday) 1852. Adron Runyon, Clerk. Meetings held. No unusual business.

August the 2 Saturday 1852. Adron Runyon, Clerk. "appointed Adron Runyon, to right a letter to the asssiation 3ly the same to notice John Smith, to his Seat".

September 2 Saturday 1852. Adron Runyon, Clerk. "motion made and seconded that Brother Richard Williamson, and Henry Runyon, talk to John Smith and prepared one dollar and 12  $^2/$  cents for printing minuets".

## APPENDIX I (i)

The following information was secured from the Minutes of the Pond Creek Church for the period extending from 1901 to August, 1949:

A. Hatfield was Moderator at various times up until 1916. The last record noticed in the minutes was August the 2nd Saturday 1916, when A. Hatfield was Moderator and T. W. Runyon was Clerk.

June, 1908. Anderson Retherford requested that the Church release him from being Clerk, which was done, and A. R. Hatfield was appointed Clerk. At this same meeting it was "Motioned & Seconded that Bro. T. G. Farley, purchase a new church book & the church to pay for it. 5" motioned & seconded that A. R. Hatfield, Transcribe all the church business from the old church books on to the new one. & the church to pay him a reasonable compensation for his services ".

July the Second Saturday, 1909. " 3- Called for the refference, that refered to brother A. R. Hatfield leaving the country under bad report, and the church after mature deliberation, excluded him from their membership. 4- The church chose and appointed brother T. W. Runyon church Clerk, permanently. ". Minutes for June 1919 were the last signed by T. W. Runyon. He was removed as Clerk on account of health in February, 1920 and Boyd Farley, who was serving as Clerk Protem, was appointed Clerk.

June the 2nd Saturday 1935, last minutes signed by Boyd Farley as Clerk.

July 2nd Saturday 1935. " It was moved and Seconed that Bro. C. J. Mickey Serve this church as Cleark in the absence of the Deceased Bro Boyd Farley ".

W. J. May acted as Moderator on occasion until 1926, last record for him in Minute Book is September the 2nd Saturday, 1926.

Last record of J. D. Riffe acting as Moderator was on the 2nd Saturday of January, 1931.
